In case the office remains closed, the Tenders will be opened on next working day at same time and venue. The Specification of the Radios may be collected from the undersigned on any working days during the office hours upto 03 P.M. on 04/02/2017 by submitting a requisition addressed to the undersigned.

Tender shall be superscripted in red ink with "VHF SET AND ACCESSORIES FOR THE YEAR 2017-18" on the top of the Tender cover. The rates so accepted will take effective from March/2017.

5. Delivery must be completed within thirty days on receipt of formal order for supply.
6. Tenderer must deposit Rs. 5000/- (rupees five thousand) only as earnest money in the form of call deposit or bank draft from a nationalized bank/ NSC/KVP. duly pledged to the Spl. Director General of Police-cum-Director of Fire & Emergency Services, Assam, Guwahati.

14. The quoted vendor should have own support office in Assam.


